

# Privacy Policy

At Opiniion, Inc. ("Opiniion") we are committed to safeguarding and preserving the privacy of our visitors. This Privacy Policy applies to any personal information you provide to us, or that we collect through our website or other electronic forms of communication. By accessing or using any part of our website or services, you agree to the collection and use of your personal information in accordance with the terms set forth in this Privacy Policy. We may update this Privacy Policy from time to time so please review this Policy regularly.

## Information We Collect

In running and maintaining our website we may collect and process the following data about you:

- Information about your use of our site including details of your visits such as pages viewed and the resources that you access. Such information includes traffic data, location data and other communication data.
- Information provided voluntarily by you. For example, when you register for information or make a purchase.
- Information that you provide when you communicate with us by other electronic means.

## How We Use Your Information

- Where we are legally required by law to disclose your personal information
- To further fraud protection and reduce the risk of fraud

## Transfer of Your Information

In operating our website it may become necessary to transfer data that we collect from you to locations outside United States of America for processing and storing. By providing your personal data to us, you agree to this transfer, storing and processing.

## Security of Your Information

We maintain physical, electronic, and procedural safeguards reasonably necessary to ensure the protection of your personal information against loss, misuse, disclosure, and alteration.
